- **Estimators:** Get results tailored just for you that helps you plan and set goals for work. Get tips for success for your individual situation.

## Property Tax Relief

The Affordable New Jersey Communities for Homeowners and Renters (ANCHOR) Program offers tax relief to New Jersey residents who rent or own property. For New Jersey renters, you may qualify if your gross income is no more than \$150,000, your name is on a lease or rental



agreement, rented a residence on October 1, 2024, and live in a rental subjected to property taxes. For New Jersey homeowners, you may be eligible for the ANCHOR benefit if your gross income is no more than \$250,000, owned a residence on October 1, 2024, and live in a home subjected to property taxes. Individuals under 65 and not collecting Social Security disability benefits will receive Anchor Benefit Confirmation Letter on August 13, 2025 with filing details. Individuals 65 and older or receiving Social Security Disability Benefits must fill out a PAS-1 combined form. On this form, seniors will be able to claim benefits for three property tax relief programs: ANCHOR, Senior Freeze (Property Tax Reimbursement), and Stay NJ on a single application. The Senior Freeze Program reimburses seniors and individuals with disabilities for property tax or mobile home park site increases on their main home. The Stay NJ Program reimburses senior homeowners 50% of their property tax bills up to a maximum of \$13,000, with a 2024 benefit cap of \$6,500. To qualify, you must own or live within your home for 12 months in 2024 and have an income below \$500,000. If you made payments in lieu of tax payments to your municipality, you are eligible for the Stay NJ benefit. However, mobile homeowners are not eligible. The deadline to apply is on October 31, 2025.
